

The WVA is a constituent member of WineGB, the national body that provides professional services for the whole of the British Isles. The other local associations are

- i) East Anglian Association
- ii) WineGB Midlands and North
- iii) WineGB South West
- iv) WineGB SouthEast
- v) WineGB Wessex

Members are allocated to the association in which their vineyard lies, although they may join a second association (on payment of the regional fee) The normal regional fee for the WVA is £30 p.a., although for 2021 it will be £0.

**Benefits of WineGB membership** 

- i) A national email discussion system for exchanging views, problems etc. This can be especially useful when you have received an email that you suspect may be a fraud.
- ii) Webinars. These give you access to panel discussions with experts on a variety of topics such as Soils, frost damage, marketing etc.
- iii) An annual magazine (Grapepress) which can be in hard copy or downloaded.
- iv) Access to advice on sprays that are legal in the UK (often referred to as 'The Green Book')
- v) A National competition on International Standards, judged by Masters of Wine.
- vi) A weekly bulletin on problems, advice etc.
- vii) Access to information/instructions issued by DEFRA
- viii) Organisation of Marketing weeks via Social media and web sites.

## Sustainable wines




